गणेशमूर्तीच्या सोवळ्यासाठी लागणाऱ्या मलमल कापडासाठी हिंदमाता बाजारपेठ प्रसिद्ध आहे. नेसावणारे सोवळे कलाकार यांची मोठी गर्दी इथे असते; परंतु यंदा केवळ १० टक्के कापड विकले गेल्याचे हिंदमाता येथील दुकानदारांनी सांगितले. ''दरवर्षी दहा ते बारा सोवळे नेसवणारे कलाकार जवळपास २० हजार मीटर कपडा घेऊन जातात. या वर्षी मोठय़ा मूर्ती नसल्याने थोडाच

माल विकला गेला,'' अशी खंत 'श्रीनाथ फॅब्रिक'चे राजेश भगेश यांनी बोलून दाखवली.
